WITH THE PASSAGE of health care reform legislation earlier this year, the stage is set to define the next steps necessary to advance high-value health care delivery in America. Building upon four years of work convening hundreds of healthcare experts and stakeholders, the Mayo Clinic Health Policy Center is hosting a symposium to determine key priorities that will further the evolution to a high-value health system. The purpose of the symposium is to:

- Identify and prioritize the most critical issues in the next one to three years to ensure that patient-centered high-value health care delivery practices thrive and spread.
- Formulate recommendations for the CMS Innovation Center by reviewing concrete examples of innovative health care delivery projects that improve outcomes and reduce costs.
- Identify and prioritize key issues that will require attention in future phases of health care reform.

Join with national leaders to build consensus on the future of high-value health care delivery. Nationally recognized health care experts will facilitate discussions at this highly participatory event. Your experiences and ideas will help influence and form the solutions.

YOUR ROLE AS A PARTICIPANT

At the symposium, attendees will be able to fully participate by offering ideas and comments and asking questions. Through instant response devices, participants will rank the ideas and immediately learn what others are thinking. All participants have a say in the final recommendations, which will become a road map for further action toward the advancement of high-value health care delivery.

BUILDING UPON THE CORNERSTONES

Since 2006, Mayo Clinic Health Policy Center has gathered hundreds of national thought leaders and other stakeholders for a series of events to help develop consensus-driven cornerstones to guide the reform process. These cornerstones are::

1. **Create Value:** *Improve patient outcomes and satisfaction. Decrease medical errors, costs and waste.*
2. **Coordinate Care:** *Coordinate patient care across people, functions, locations and time to increase value. Ensure patients' active participation in the process.*
3. **Reform the Payment System:** *Change the way providers are paid in order to improve health and minimize waste.*
4. **Provide Health Insurance for All Americans:** *Provide guaranteed, portable health insurance for all citizens, giving them choice, control and peace of mind.*

This is the framework that will guide discussions during this symposium.
